# New ID Card

In December, you'll receive a new medical ID card with a new member and group number. You must share this card with your pharmacy and your doctors beginning January 1, 2025, as your old card will no longer be valid. you'll use the new card to access medical, prescription drug, and behavioral health benefits and the services of the Employee Assistance Program.

# What You Need to Do

- Look out for your new ID card, which will be mailed in
- December.

   Beginning January 1:
- o Make sure that your pharmacy has your new card on file.
- o Give doctors and medical facilities your new card.
- o <u>Log in to MyCPG Accounts</u>, where you can register on Quantum's site for future access.

# Transition of Care

Anthem and Cigna will provide Quantum with approved authorizations for treatments that will take place in 2025. You may call Quantum in December to confirm that all necessary authorizations are in place and thus ensure there is no disruption in your care.
